If you use the dog park, please be courteous to other Homeowners and DO NOT park in their driveways or in front of their homes. Nevada law, NRS 484.399, prohibits stopping, standing, or parking within 5 feet of a public or private driveway.

Dogs must be kept on a leash until you are in the dog park.


***Snow Removal Reminder

Per Washoe County Ordinance 85.365, homeowners are responsible to keep the sidewalks adjacent to their property clear of snow. If you live on a corner lot, you must clear the entire sidewalk along your property. When removing snow from your sidewalks and driveways, the County requests that gutter areas be kept clear of debris and snow to ensure proper drainage. If a mailbox is on your property, please remove snow as soon as possible to facilitate delivery of the mail.

Washoe County is responsible for snow removal of our public roads. Main roads are cleared first and cul-de-sacs are secondary. The County requires vehicles to be removed from the streets after a snow so that the roads may be plowed.

Christmas Tree Recycling

Please dispose of Christmas trees properly. Waste Management request that your tree be cut into thirds and put in your garbage can. Also, trees can be taken to



one of the following locations, between 9:00am and 4:30pm until January 18, 2010. They request that you remove all foreign matter from your tree prior to dropping it off at the recycling location. Flocked trees,

wreaths and other yard waste are NOT accepted. A minimum \$3 donation is recommended to support this and other valuable community programs.
